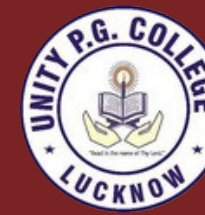

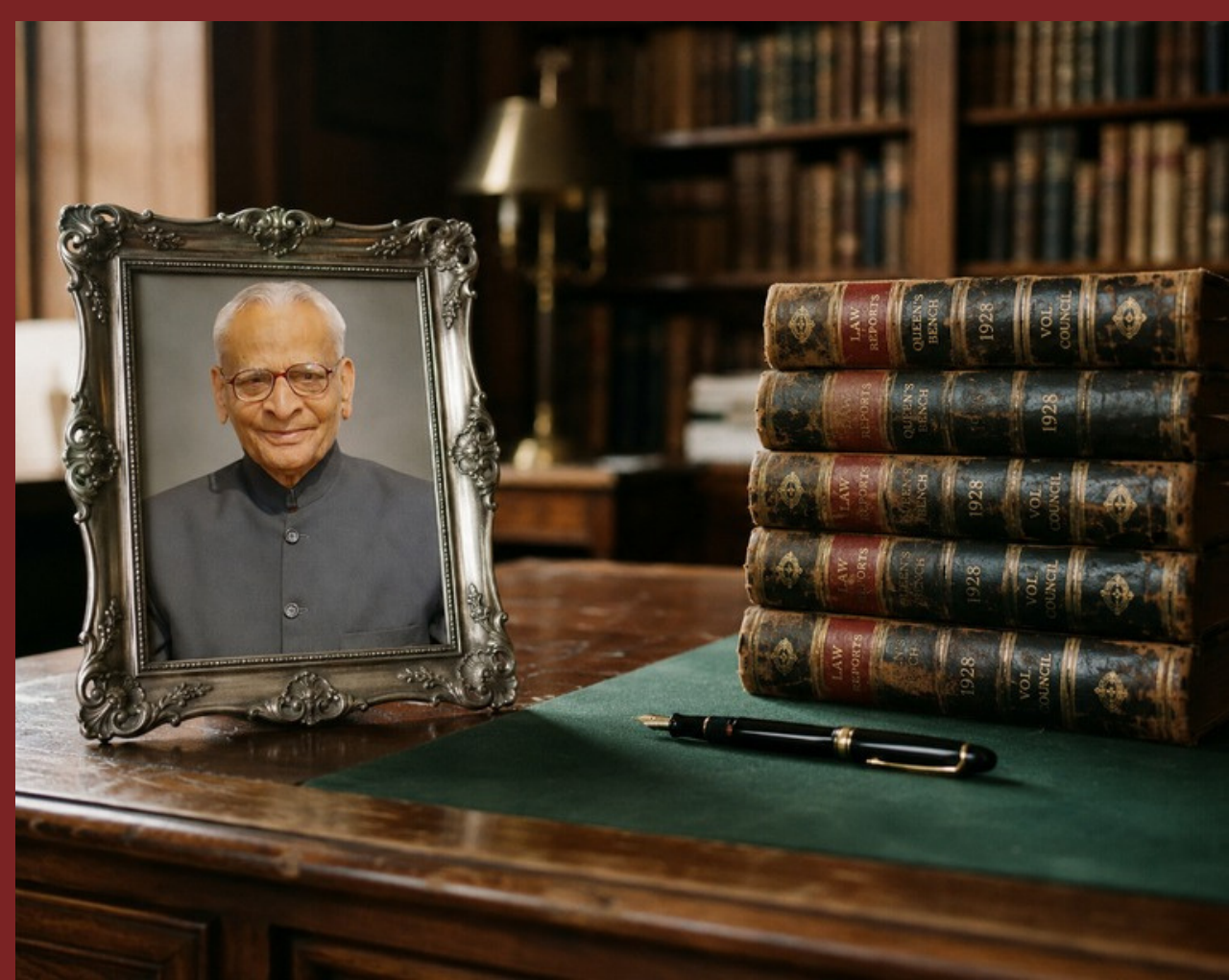
Hon'ble Mr. Justice Murtaza Husain

(1920–2012)

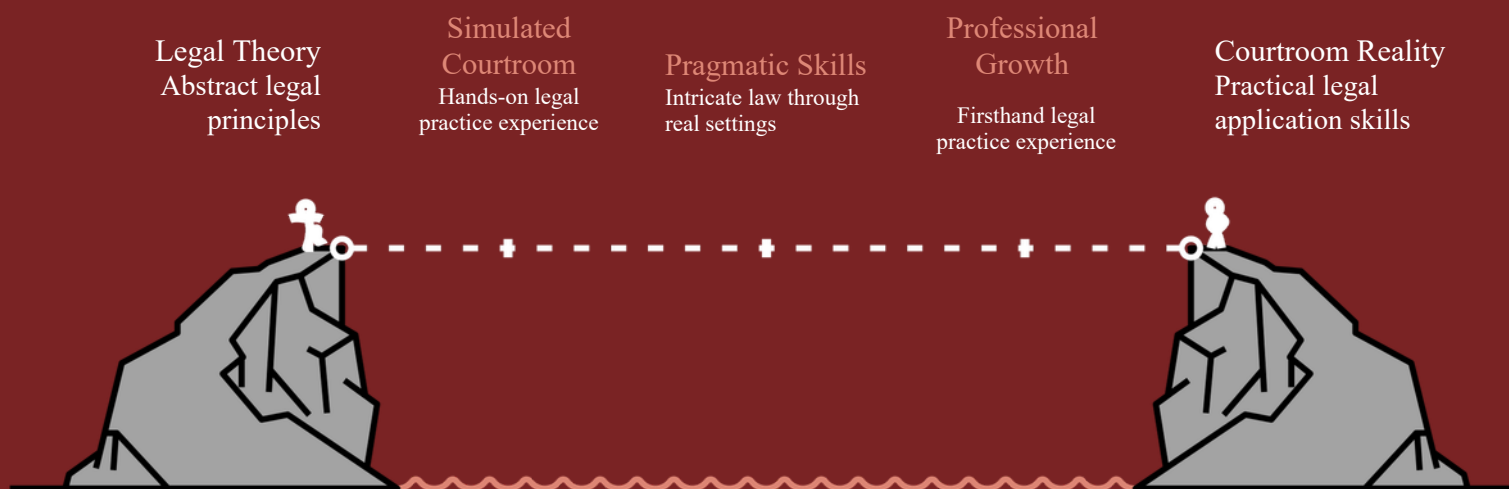

Our honourable founder was born on 8th December, 1920 in the historical town Faizabad, India. After completing his LL.B. from Canning College. Lucknow, he became a Munsif in the year 1944. In 1968, he became District Judge, in the year 1976, he was elevated as a Judge in Allahabad High Court. After his retirement, he was appointed Lokayukta of Uttar Pradesh for six years. His decisions in some of the very complicated litigations are and will always remain landmarks in the history of Law. He was a voracious reader and connoisseur of English, Urdu and Persian literature and poetry. He authored many books on different subjects in addition to his autobiography. In 1996, Unity Technical Institute Society was established by him with the main objective of providing professional and technical education to all, especially to those belonging to the minority communities and other educationally backward classes.

Thereafter, in the year 1998, Justice Murtaza Husain founded Unity P.G. College. Unity P.G. College was the first self finance minority institution of North India. Today, the College is a P.G. college, having been upgraded in 2018. Unity P.G College is his dream child. He often used to say that he loved the College as intensely as he loved his children. He was a saint by all standards who spent the earnings of his lifetime in establishing this institution. His legacy will carry on through his values, thoughtfulness and compassion for all persons which find manifestation in the deeds of his lifetime. We all are proud to be a part of his mission.

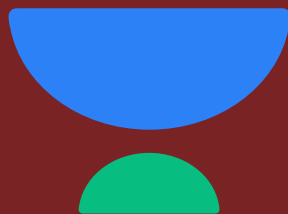
